Why should I attend?

Osteopathic education places increasing challenges on its academic staff as we respond to the national and international changes in osteopathy and its teaching. This conference brings together best practice from our international partners, allowing delegates to gain new information and to share experiences and problem solve issues from their own institutions.

Workshops

Clinical Assessment

This workshop will address contemporary issues in assessment of clinical practice. Chaired by Simeon London, Head of Clinical Practice at the BSO, there will also be presentations from Sarah Wallace (osteopath, international external examiner and previous Chair of the GOsC Education Committee) on issues in clinical practice and assessment in central Europe, and John Patterson (Honorary Senior Lecturer, Centre for Medical Education, Barts and the London School of Medicine and Dentistry) on clinical assessment in medicine.

Assessing Practical Skills

This workshop will look at the technique area, and the way that it is taught and assessed in the different manual therapies. Bex Morrison, M.Ost Course Leader at the BSO will chair the session, with contributions from institutions that teach physiotherapy and chiropractic. This session will enable delegates to compare and contrast teaching methods and types of assessment used and their value.

Dissertation Supervision & Assessment

With most UK qualifications at masters degree level, this workshop looks at the challenges of supporting and supervising student dissertations. Jorge Esteves, Head of Postgraduate Education at the BSO will chair the session and present on dissertation supervision, with co-presenters Marjolaine Dey, Head of Student Dissertations, CEESO, Paris who will present on the challenges of effective dissertation supervision in osteopathy and Jocelyn Gentil-Becoz, Head of Student Dissertations, CEESO, Lyon who will summarise best practice regarding assessment of dissertations.

Parallel sessions

Drawn from a call asking for papers regarding the themes below:

Undergraduate course innovation

Reflecting the depth and breadth of innovative undergraduate osteopathic education and practice, relating to an overall course structure, or the development of any specific area of study.

Postgraduate challenges

Postgraduate study leading to formal qualifications, or addressing revalidation and continuing professional development addressing practitioners' needs in practice.

Teaching and technology

Identifying the range of methods and technologies used in teaching osteopathy and manual therapies, including e-learning and virtual learning environments.
